



As a precautionary measure and to help slow the spread of the Coronavirus (COVID-19), Foothills Bank has decided to conduct all face-to-face Customer transactions through the Drive-Thru only. Branches without a Drive-Thru will offer supplementary accommodations. Even though the doors may be closed, we are here to help you with most of your financial needs. Each Branch will offer numerous ways for you to safely and conveniently conduct your transactions with as little interruption as is possible.

Drive-Thru

Customers can use the Drive-Thru to withdraw cash, make cash and check deposits, make transfers, make loan payments and advances. Drive-Thru tubes and speaker boxes are sanitized regularly.

Transaction Limitations

- Cash withdrawals are limited to \$2,500.00
- Coin totaling over \$5.00 will not be accepted or given at the Drive-Thru
- 2 forms of ID may be required
- Facemasks must be removed briefly to allow for proper identification
- Branch access will not be permitted
- No wire transfers, notary services, savings bond redemption or cashier's check purchasing

Night Drop

The Night Drop is a secure vault like a US Postal Service mail drop. Just pull the handle back, drop in your envelope, and close the lid to finish. Your envelope will drop into a secure vault where two employees will secure those transactions and post the transactions. Make sure you seal your envelope or bag and include a deposit slip or clear instructions of the transaction request.

Example: Please deposit \$200.00 into my checking account ending in 1234 and deposit the rest into my savings account ending in 4321.

Transaction Limitations

- No withdrawals, cash back, or transfers
- Transactions will posted the same business day, refer to our funds availability policy
- No wire transfer requests
